I, the undersigned, understand the nature of the affidavit of probation violation against me.

I understand that I have a right to be represented by an attorney at all stages of the proceedings, and if I cannot afford an attorney, to have the Court appoint one.

1. The right to a hearing.
2. The right to use the power of the Court to subpoena witnesses and present evidence on my behalf, including my right to testify on my own behalf.

4. The right against self-incrimination, which means the right not to testify against myself. My decision to admit the violation(s) has been made freely and voluntarily without threat or fear to me or anyone closely related to or associated with me. There have been no promises to me of rewards, immunity, probation, or anything else to induce my admission, except _____
